CONFLICTS OF INTEREST

Conflict of interest is defined as a situation in which the nature of work under this contract and the Proposer's organizational, financial, contractual or other interests are such that:

- Award of the contract may result in an unfair competitive advantage.
- The Proposer's objectivity in performing the contract work may be impaired. In the event that Proposer has an organizational conflict of interest as defined herein, the Proposer shall disclose such conflict of interest fully in the proposal submission.
- Proposer agrees that if after contract award he or she discovers an organizational conflict of interest with respect to this contract, he or she shall make an immediate and full disclosure in writing to the CEO of the SPHA which shall include a description of the action which Firm has taken or intends to take to eliminate or neutralize the conflict. SPHA, may, however, terminate the contract if it is in its best interest.
- In the event the Firm was aware of an organizational conflict of interest before the award of this contract and intentionally did not disclose the conflict in writing to the CEO of the housing authority, SPHA may terminate the contract for default.
- The provisions of these Conflicts of Interest shall be included in all subcontracts and consulting agreements wherein the work to be performed is similar to the service provided by the Proposer. Proposer shall include in such subcontracts and consulting agreements any necessary provisions to eliminate or neutralize conflicts of interest.
- No member of the SPHA Board of Commissioners shall be allowed to share any or part of this contract or to derive any benefit to arise there from. This provision shall be construed to extend to the contract if made with a corporation for its general benefit.
